~ About CISIP~

The CISIP is an initiative of China Great Wall Enterprise Institute to create a professional and practical platform for the world's science-industry parks (SIPs) to share expertise and join efforts to confront common challenges, achieve high-quality, sustainable growth, and ultimately enhance SIP's status and prominence as an effective tool of socio-economic advancement, especially in developing contexts. The community aims to fulfill this mission by facilitating international professional communication, innovative business cooperation, and SIP management consultation.

As a non-governmental, non-profit organization, the CISIP follows the core values of professionalism, inclusiveness, and independence, indicating its openness to freewill and fee-free participation from around the world with no more criteria to filter membership other than professionalism. Sponsorships on which the community rely for operation and functioning does not affect its independence of action.



~ Membership Policy ~

Memberships must be applied by legal representatives or those authorized by legal representatives of above-mentioned types of institutions in the name of the institution. Natural persons apply on behalf of themselves.

No fee in any form will be needed to register and remain as a member of CISIP. It is only requested to fill in the Registration Form in this document to become member, which is necessary for keeping the community professional and enabling the community to provide useful services to its members.

Information collected from members will only be used in the community's management activities including communication among members for purposes of networking and exchanges, and academic research activities including statistics and analysis. Information will NOT be used for commercial purposes, and will NOT be leaked to any third-party without informed consent of members' legal representatives.

Members are encouraged to take part in activities and other initiatives offered by the community and fellow members, and to take initiative to bring up ideas and offers of collective activities and topics of discussion, which is NOT mandatory. Members are welcome to become sponsors of the community, and should behave in favor of the community's unity and common interests.

In order to keep the community active, memberships must be confirmed valid on a regular basis, for which purpose a members' survey will take place every year through emails. Two sequential unresponded survey requests will lead to automatic termination of memberships, after which no more updates from the community will be shared to the member. Memberships can also be terminated on members' own will with an official letter of request.

By submitting the registration form, the member is considered well informed of the community's policies and agrees to accept all terms and conditions. As the initiator and secretariat of the community, China Great Wall Enterprise Institute reserves the right of amendment and final interpretation of CISIP's policies. (End of Text)
